1. Remuneration : Rs. 1000/- per class up to the maximum ceiling of the 30,000/- in a month.
2. Period of engagement : The period of engagement under this offer shall be valid for 03 months.
3. This engagement is made purely on temporary and contractual basis for a fixed period.
4. Selected candidate is not entitled to any other benefit such as Confirmation, LTC, Medical reimbursement etc. which is admissible to the regular employees of the University.
5. There will have no claim for regularization/seniority on the basis of this engagement.
6. The University reserves the right to terminate this engagement any time even before the stipulated time, without assigning any reason.
7. Selected candidate will have to perform the teaching and other duties as assigned by the Director of the Campus/Head of the Department which is subject to review from time to time.

8. Selected candidate will be required to engage classes / duties in the campuses as per its requirement in accordance with the directive of the University/directions of Director of the campus.
9. During the tenure of the above engagement, the part time Guest Faculty will not engage himself/herself in any other assignments.

#### **Guest Faculty (Assistant Professor Grade)**

- i. A master's degree with 55% marks (or an equivalent grade in point scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign university.
- ii. The candidate must have cleared the National Eligibility Test (NET) in concerned Discipline, conducted by the UGC or the CSIR, or must have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time.
- iii. Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutions subject to the fulfillment of the following conditions :-
  - a. The Ph.D. degree of the candidate has been awarded in a regular mode;
  - b. The Ph.D. thesis has been evaluated by at least two external examiners;
  - c. An open Ph.D. viva voce of the candidate has been conducted;

  - e. The candidate has presented at least two papers based on his/her Ph.D. work in conferences / seminars sponsored / funded / supported by the UGC / ICSSR / CSIR or any similar agency.
  - f. The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

(i) Quacquarelli Symonds (QS) (ii) The Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai), Desirable : Knowledge of Sanskrit.
