The scheme enables collateral free, guarantor free education loans by banks through a simple, transparent, student-friendly and digital application process.

A virtual meeting chaired by the former Chairman, UGC regarding implementation of PM-Vidyalaxmi Scheme in Quality Higher Educational Institutions (QHEIs) was held on 26.03.2025, where all the QHEIs were apprised about the salient features of the scheme by Ministry of Education and Nodal Bank i.e. Canara Bank.

During the review meeting held by Hon'ble Finance Minister on 13.5.2025, it was inter-alia advised that steps should be taken to improve the awareness of the scheme among the students who are seeking admission in these QHEIs.
