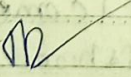
The meeting was started at 2pm with a warm welcome by the campus Director Prof. K. Mishra. Important points discussed in this meeting are summarized below.

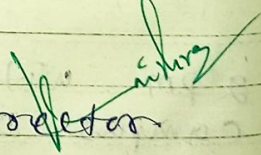
- 1- Campus Director Prof. K. Mishra initiated the meeting by appreciating the participation of all members and welcomed all of them.

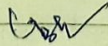
- 3- Director mentioned about the discipline in the campus and there are no contemporary issues like sexual harassment and gender discrimination till date.

5. Meeting was ended up with the discussion that all members of the committee have work hard ~~and order~~ to bring about the safe working environment with respect to human rights.

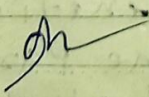
At the end Tea programme was arranged as refreshment for the meeting.

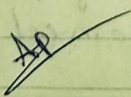

Item No - 3

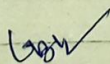
women student representatives to be included in the committee so that the girl students will be able to share with the fellow students, the measure that are being taken towards sexually harassed students in the college.

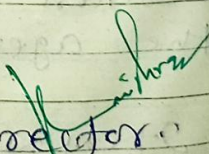
Item No - 04
