It is notified for information of all concerned that pursuant to section 9 (8) of the Central Sanskrit It is notified for information of all concerned that pursuant to section 9 (8) of the Central Sanskrit Universities Act, 2020 and consequent upon establishment of Research & Development Cell of the CSU at its Ganga Nath Jha Campus, Prayagraj, Hon'ble Vice Chancellor of CSU is pleased to appoint Prof. Lalit Kumar Tripathi, Professor (Vyakarana) as Dean of Research in Central Sanskrit University for a period of 03 years or till further orders, whichever is earlier.

Prof. Lalit Kumar Tripathi shall be responsible to the Vice Chancellor, Central Sanskrit University, Delhi for his duties and responsibilities as Dean of Research in CSU.

The duties & responsibilities of Prof. Lalit Kumar Tripathi, Dean of Research shall be as following:-

- i. He shall recommend steps for the coordination of activities towards strengthening the Research efforts and initiatives of the University;
- He shall advise the Vice Chancellor in the formulation of guidelines for the submission of research projects to funding agencies and the undertaking of consultancy projects by faculty groups & individual faculty members and perform such functions as may be assigned by the Vice Chancellor in respect of institutional support for and the monitoring of the progress of such research and consultancy projects;
- iii. He shall provide linkages with academic and research institutions, governmental, industrial and business concerns as well as research organizations for offering the expertise and facilities of the University for research and consultancy projects, and executing collaborative and sponsored programmes, including the strengthening of research facilities in the University with their support;
- He shall provide advice and support to faculty members and researchers in the filling of patents and other aspects of the generation and protection of intellectual property rights;
- He shall take steps for promoting Technology Development Mission Projects, Technology Transfer initiatives and organizing Specialised Workshops and Entrepreneurship Development courses or programmes for their benefit;
- He shall generally provide advice and support in respect of the promotion of Research activities in the University.
- He shall perform other duties/responsibilities concerned with Dean of Research as prescribed in the Act and the Ordinance.
- He shall also perform any other duties as entrusted by Vice Chancellor, CSU, Delhi viii.
