Dear Scholar/Nodal Officer,

The National Fellowship for Scheduled Castes Students (NFSC) Scheme is a scheme funded by the Ministry of Social Justice & Empowerment (MoSJ&E), Government of India.

National Scheduled Castes Finance & Development Corporation (NSFDC) is the implementing agency for the said Scheme, w.e.f. 01.10.2022.

As per the instructions of the Ministry of Social Justice & Empowerment (MoSJ&E), Aadhaar Authentication in the Scholarship & Fellowship Management Portal (SFMP) has now been made mandatory for the NFSC Scheme. Accordingly, the Scholars are requested to perform their Aadhaar Authentication in SFMP, not later than 31st May 2024.

It is important to note that the fellowship shall be released only to the Scholars who have successfully performed their Aadhaar Authentication in SFMP. Further, the fellowship will be transferred to the Aadhaar Seeded bank account of the Scholars.

In case Scholar has more than one Bank Account and wishes to receive their fellowship in a certain account then the Scholars are advised to visit the Branch of the concerned Bank and get their Bank Account as Aadhaar Seeded.

A detailed walkthrough for Scholars and University/College's Nodal Officer to perform Aadhaar Authentication in SFMP is attached herewith and is also avaliable on the website of NSFDC (https://nsfdc.nic.in/UploadedFiles/other/2024-02-26/aadharseedingguide26022024.pdf).
